Dear Senators and Representatives:

The undersigned organizations are writing today in support of the budget conference report containing the Senate's provision regarding the tobacco tax. Not only does this provision make good public health sense, it provides one important funding source for the reauthorization of the State Children's Health Insurance Program (SCHIP). As the Congress moves towards reauthorization of SCHIP, it is important that committees of jurisdiction have available to them every possible funding source.

Reauthorizing SCHIP is one of the most important tasks before Congress this year. Together, SCHIP and Medicaid have significantly expanded children's health coverage and improved the health care low-income children receive. Reauthorization offers us the opportunity to strengthen and build on the success of these important health coverage programs.

Both the House and the Senate have recognized the need to reauthorize and fund SCHIP, each house pledging \$50 billion in new dollars above the baseline for the program. However, due to the "pay-as-you-go" rules adopted by each chamber, the Senate Finance Committee and the House Energy and Commerce Committee will have to find offsets for the spending.

The tobacco tax provision that passed on the floor of the Senate with a strong bipartisan vote is one such option for raising some of the necessary revenue for an offset. The current federal tobacco excise tax has not changed in nearly five years and is no longer a serious disincentive to smoking. Studies show that every 10 percent increase in the price of cigarettes reduces youth smoking by seven percent and overall cigarette consumption by about four percent. By including this bipartisan language, Congress can greatly reduce the number of kids who take up this deadly habit and reduce tobacco-related health care costs.

We thank the Budget Committees for recognizing the importance of SCHIP reauthorization with the additional money to cover uninsured children. We now strongly urge the Conferees not to tie the hands of the Committees before a real conversation on how to pay for SCHIP can take place. Leave all options for "pay fors" on the table and maintain the tobacco tax provisions in the budget conference report.
