Comments on Revised Policy Proposals	<p>There are 15 proposed policies. Members reviewed policies related to health disparities/international health, env health, and public health science &amp; infrastructure at <a href="http://www.apha.org/advocacy/policy/2009proposedpolicies.htm">http://www.apha.org/advocacy/policy/2009proposedpolicies.htm</a>. It was recommended that the section not support two policies: B1- The Elimination of Asbestos and Adequate Compensation for Victims because it did not add any new issues to a similar previous policy, and B3-Calling for Precautionary Avoidance of Non-Medicinal Hormones, especially those intentionally added to the food system because it was not based on research findings. On B6- Reducing the Burden of Poor Health and Health Inequities through transportation and land use policies, there were questions on whether it added any new information, and specificity of the action steps.</p> <p>Two policies in the Access to Care categories, including “Public Health’s Critical Role in Health Reform” co-authored by a CHPPD member and supported by the section was not reviewed.
