Dear Senators Inouye and Cochran and Representatives Obey and Lewis:

As you move forward with conference of the Fiscal Year 2010 Labor, Health and Human Services, and Education (Labor-HHS) appropriations bill, on behalf of the undersigned local, state, and national organizations committed to the health and well-being of our nation's young people, we urge you to follow-through in eliminating funding for all abstinence-only-until-marriage programs and funding the most comprehensive prevention initiative possible.

We are encouraged that both chambers of Congress agreed with the President in eliminating funding for existing abstinence-only-until-marriage programs and, in their stead, funding more comprehensive approaches to sex education. **We fully support this shift from funding ineffective abstinence-only-until-marriage programs to spending federal funds on an evidence-based and comprehensive approach to sex education.** After more than 25 years and more than \$1.5 billion of wasteful spending on ineffective abstinence-only-until-marriage programs, Congress has the opportunity to meet the needs of all young people by crafting a program that includes information about both abstinence and contraception and addresses the root issues that help teens make responsible decisions and keep them safe and healthy.

The House provides a total program funding level of \$114.455 million while the Senate funds the initiative at only \$104.455 million. **We urge Congress to fund the program at the higher funding level.**

We need to invest in a holistic approach that provides all of our young people with comprehensive, medically accurate, and age-appropriate sex education that helps them reduce their risk of unintended pregnancy, HIV/AIDS, and other sexually transmitted infections (STIs). The House bill focuses exclusively on funding teen pregnancy prevention programs while the Senate bill takes an appropriately broader view and supports funding for "improving the reproductive health and well-being of young people" through efforts aimed at both reducing unintended teen pregnancy as well as STIs, including HIV. **We strongly urge Congress to enact a broad initiative that addresses unintended teen pregnancy, as well as STI, and HIV prevention.**

We are also concerned about the sustainability of the initiative should it remain administered exactly as the competitive abstinence-only-until-marriage grants program has been administered. Furthermore, the initiative must address the often unmet and interrelated health needs of adolescents and be linked to public health outcomes. Therefore, **we urge Congress to follow the Senate language and ensure that the new initiative is invested in multiple agencies of the Department of Health and Human Services (HHS).** The Senate directs funding to be a collaboration between HHS agencies including ACF, CDC, and OPA and we fully support this inter-departmental approach. The agencies within HHS all have a role to play in ensuring that this new teen initiative is as successful as possible and is able to be implemented effectively by public and private entities, as indicated in both the House and Senate versions of the bill. It is essential that they all work together and collaborate on this public-health driven program.

Congress is well on its way to acting in the best interest of young people by supporting public health and education policies that are comprehensive, rooted in the best science, and reflect mainstream values. We urge you to finalize the strongest possible initiative that will meet the needs of all young people and will be sustainable in the long term.
