### 2. Executive Board and JPC update – Anne Dressel

- i. Executive Board Update:
  - i. There is a workgroup reviewing and coming up with a plan for moving forward based on the MUEEP (Member Unit Effectiveness and Engagement Project) survey responses.
  - ii. Upcoming Annual Meeting will be in person in Denver with some sessions held virtually. Registration opens July 1 please share this info with your sections.

- ii. JPC Update:
  - i. JPC met to review <u>20 proposed policy statements</u> on April 29-30. Nineteen proposed statements received conditional assessments and one received a negative assusment.
  - ii. Authors will receive letters from the JPC with the JPC's disposition on each proposed policy statement (positive, conditional or negative) by May 21, and authors are to resubmit their revised proposals addressing the JPC's comments by Aug. 13.
  - iii. 26 current policy statements <u>up for archiving</u> this year. These statements are from 2002.

## 3. Legislative/federal update – Don Hoppert/Jordan Wolfe

- ii. National Public Health Week advocacy:
  - i. 22 meetings were scheduled with Senators from 16 different states.

- ii. Average of 4 participants per meeting (range from 1 to 7)
- iii. All reported discussing PH funding + other issues such as racial equity, gun violence, climate change, tobacco, substance use.
- iv. 258 advocates sent action alerts during NPHW for a total of 1389 messages sent to Congress this is up from previous average of 65 advocates / 135 messages per week.
