Candidate Profile: Provide your name and contact information, along with citizenship status, current affiliation, degrees, discipline, areas of public health expertise, areas of policy interest and a brief bio **not to exceed 200 words**.

Candidate Statement: Provide a statement about your qualifications for the fellowship and your career goals, not to exceed two pages (1,000 words). The Candidate Statement must address each of the following five points:

- **Rationale:** Reasons for applying for the APHA Fellowship.
- **Qualifications:** A summary of your background and expertise – what can you contribute to the fellowship.
- **Areas of Interest:** Outline the policy areas or issues that you are particularly interested in addressing in a fellowship.
- **Career Goals:** State your future goals following the fellowship, and how you envision the fellowship supporting those goals.

Curriculum Vita: Provide a curriculum vita not to exceed four pages. Use

your CV to highlight your education, expertise, achievements and honors, and your publications. The CV should not repeat information included in the extracurricular section.

Extracurricular activities: In one page (500 words), provide brief examples of your activities beyond your professional role and your actions and accomplishments in those efforts. These might

include activities with community groups, professional associations, advisory and editorial committees, nonprofit organizations, outreach and teaching to non-scientific audiences, etc.

References: Three recommendation letters are required. Additional letters will NOT be accepted. You are responsible for ensuring that APHA receives these recommendation letters directly from your references by 6 p.m. eastern on Sept. 4, 2018.

Letters of recommendation are an essential and important component of the application. They must be from individuals who can comment on your professional competence and other qualities and interests that

make you qualified to serve as a Fellow. Select your references carefully. It is helpful for your references to review the criteria and information on the fellowship to which you are applying in order to target comments appropriately.

References should be given ample notice to write a solid recommendation on your behalf. Recommendation letters are confidential and must be submitted directly by the reference to APHA at: APHA Fellowship Program, 800 I Street, NW, Washington, DC 20001 or by email directly to: aphafellowship@apha.org.

Receipt of applications and letters of recommendation are acknowledged via email. Please do not contact the APHA staff to inquire about the status of application materials. All application materials are confidential and become the property of APHA.
