





## Role of Governing Councilor and Speaker





**Functions of Governing Councilors (see Bylaws)** 

- Adopt policy statements
  - APHA's position on public health issues to impact legislation and regulation.
- Amend bylaws and to adopt rules of business.
- Approve schedule of dues
- Elect the Executive Board and Officers
- Recognize Affiliated Associations
- Approve the establishment, combination, or discontinuation of Sections
- Approve the establishment or dissolution of boards and standing committees



**Functions of Governing Councilors (see Bylaws)** 

- Establish special committees and task forces
- Receive reports and act upon recommendations from any Association constituent, Board, Committees and Councils
- To make available to the general membership the approved minutes of each of its meetings.
- To elect the Nominations Committee.
- To elect honorary members.

#### **Access to Meetings**

 Governing Council meetings are open and may be attended by all members. Minutes are posted to the web following approval by the Governing Council.





#### PROXY

- IF you cannot attend a GC session you can arrange for a proxy. Proxies can be appoint for both the Mid-Year meeting of the GC and GC Sessions at the Annual Meeting
- PROXY a current APHA member who is NOT an elected Governing Councilor
- In general Section chairs and Affiliate Presidents (or ARGC) may appoint a proxy
- PROXY is registered for an entire session and can SPEAK & VOTE.



Planned Sunday Sessions (10/26) – GC members *might* wish to attend.

- Leadership Roundtables (9-11a.m.) Listening Sessions on Member Unit Effectiveness and Engagement Project (MUEEP) with Brighter Strategies team
- Policy Hearings (3:30-6 p.m.) OPEN TO ALL MEMBERS. An opportunity to provide input into review of all of the resolutions and late breaker policy statements that will be voted on during Tuesday's sessions.



# What constitutes a majority vote by the Governing Council?

- For a majority of votes, including approval of proposed policy statements, election of officers and approval on annual meeting themes, a simple majority (over 50%) is needed for approval
- Proposed bylaws amendments require approval by 2/3s of the Council
- Changes to the schedule of dues for APHA membership, multiple section membership, and Affiliated Associations based on recommendations of the Executive Board also require approval by 2/3s of the Governing Council
- A quorum (over 50% of the total body) must be present for the Governing Council to hold a vote.

What is the term length for Governing Councilors and is there a maximum number of terms an individual can serve as a GC?

- Governing Councilor terms are two years
- There are no term limits outlined in the APHA Bylaws for Governing Councilors

# Does the term length of a Governing Councilor change if a proxy is appointed?

 No- The term of a Governing Councilor is two years, regardless of how many times a proxy is appointed over those two years.



When will a decision be made as to whether the 2020 Annual Meeting will be held in person?

- As of April 2020, APHA is moving forward as if the Annual Meeting will take place as planned. However, due to the COVID-19 pandemic we are weighing all of our options, including:
  - Hosting a hybrid online/in person Annual Meeting
- A definitive answer on how APHA will proceed with the 2020 Annual Meeting will be made in early July. Early-bird registration will open following this decision.

## **Role of Governing Councilor in Policy** Statement Process





#### Joint Policy Committee (JPC)

- The Joint Policy Committee consists of 12 members from the Science Board, Education Board, and Action Board. The chairs of each Board serve as the co-chairs of the JPC.
- The JPC is charged with overseeing the annual policy statement development process.
- The JPC reviews and assesses (taking into consideration recommendations of the Science Board and APHA membership) all proposed and late-breaking policy statements and reports its final recommendations for adoption to the GC at the Annual Meeting.
- The JPC also oversees (with review by the Science Board) the Association's Policy Statement Archiving and Review Process.
- All policy statements are put forward for Governing Council review (unless the policy statement is voluntarily withdrawn by the author or originator).

# Can you discuss what policy statements cover? How are they used and what is their potential impact?

#### • What is a policy statement?

APHA members develop policy statements on key public health topics, from obesity to breastfeeding to control of infectious diseases to eliminating health disparities. Proposed policy statements only become official APHA policy statements after approval by the APHA Governing Council at the Annual Meeting.

#### • How can I use APHA policy statements? Our policy statements:

- help shape APHA's position on legislation and regulations.
- are used to write briefs and statements on many public health issues.
- highlight the latest research on specific public health topics.
- are the source of information for reference and resource information for the public, such as infographics, fact sheets and reports.

# **Policy Statement Approval Process**

- February- Proposed policy statements are submitted and posted to web
- **March-** Science Board and the JPC, as well as sections/SPIGS and individual members, review and submit comments.
- May- Science Board and JPC meet. JPC provides 1<sup>st</sup> assessment of proposed policy statements:
  - Positive: Meets policy statement guidelines and only minor changes suggested
  - Conditional: Meets policy statement guidelines but some revisions and re-review are required
  - Negative: Does not meet policy statement guidelines and/or there are major flaws



#### **Policy Statement Approval Process**

- **August-** Revised proposed policy statement are submitted
- September- JPC conducts another review of the revised proposed policy statements and make 2<sup>nd</sup> assessment:
  - Positive: Proposal is ready to move onto the public hearings (with possible minor revisions needed prior to hearings)
  - Negative: Withdraw from the review process and resubmit in next year's proposed policy statement development process is recommended
- October 15- Late Breaker proposed policy statements are due. A late-breaker is a proposed policy statement that is related directly to events that occur after the regular policy statement proposal submission deadline has passed.
- Annual meeting- Public hearings are held (Sunday, Oct. 25, 3 6 p.m.) to solicit comments from authors and members on revised proposed policy statements. JPC then meets and final drafts of policies and recs are sent to GC Monday night.



#### **Policy Statement Approval Process**

- Governing Council Votes to Adopted Policy Statements
- At Tuesday GC meeting, JPC Cochairs present the JPC's policy recommendations.
- GC then votes and adopted policy statements become official APHA policy statements, useful to APHA staff, members, and other organizations for advocacy purposes.

# **Tips for Governing Councilors**

- Review original and revised proposed policy statements
  - February
  - August
  - October
- Review JPC assessments and comments to authors
  - May (1<sup>st</sup> Assessment)
  - September (2<sup>nd</sup> Assessment)
  - Annual Meeting (Final Assessment)
    - Proposed policy statements and assessments will be posted <u>here</u>
- Review the updated <u>Policy Statement Development Process and</u> <u>Procedures</u> and <u>Author Guidelines</u>
- Talk with your policy chairs to understand Member Units assessment of each proposed policy statement



#### **Question from the audience**

# Is there a way to open the policy statement process up to address COVID-19 and issues related to the pandemic?

- We do have a process for dealing with events/issues that emerge after the regular policy statement deadline has passed known as "<u>late-breaker policy statements</u>." The deadline for late-breaker statements is Oct. 15, 2020.
- Late Breakers are submitted in the same format as policy statement in the regular process. However, since they undergo a less rigorous review during the year, if adopted by the Governing Council at the Annual Meeting, approved late-breaker policy statements are considered interim policy statements for one year. Late-breaker policy statement authors will need to revise, update, and resubmit their policy statements to the standard proposed policy statement review process by the February deadline the following year.
- The Joint Policy Committee will meet in early May and will discuss then if it will make any changes/recommendations to the late-breaker policy statement process to handle proposed policy statements related to COVID-19. However, as it stand now, a propose policy statement on COVID-19 or related issues would likely meet to the criteria of a late-breaker. Authors should follow the late-breaker process/timeline.
- Speaker Murray also plans to address this issue with the Executive Board during their May meeting

# Parliamentarian and Adapted "Roberts Rules"





#### **Role of Parliamentarian**

- Serves as Speaker's advisor on matters of procedure
- Assists Speaker on parliamentary questions that arise
- Works as advisor only
- Advice is nonbinding
- Not entitled to vote, make motions, debate or address the body



#### **Purpose of Parliamentary Procedure**

- To facilitate the transaction of business
- To promote cooperation and harmony
- To ensure that the minority is respected and heard.



#### **Principles Of Parliamentary Procedure**

- Councilors have equal rights, privileges, and obligations; rules must be administered impartially.
- The minority has rights which must be protected.
- The simplest and most direct procedures should be used.
- Logical precedence governs introduction and disposition of motions
- Only one question can be considered at a time.
- Councilors may not make a motion or speak in debate until they have risen and been recognized.
- Councilors must not attack or question the motives of other Councilors.



#### **Principles Of Parliamentary Procedure**

- Councilors must confine remarks to the question that is subject to debate.
- Remarks by councilors are addressed to the speaker.
- In voting, Councilors have the right to know what motion is before the body.
- Councilors have the right to know what affirmative and negative votes mean.



Motions: Formal statement of a proposal or question to the body for consideration and action.

TO MAKE A MOTION:

- Rise and go to the closest microphone.
- Wait to be recognized by the Speaker.
- State your name and section or position.
- Propose the motion as long as no other motion is on the floor.



### **Stating a Motion**

- "Madame Speaker, I move...state your motion to be considered."
- Someone must second the motion if it is to be considered.
- The speaker will restate the motion.
- Once the motion has been restated, it belongs to the body and cannot be withdrawn without their permission.



#### **Seconding a Motion**

- Rise or speak loudly without recognition from the Speaker.
- May be asked to identify self for the record.
- Say…"Second."





### **Amending a Motion**

- To modify the wording in the main motion without changing the entire meaning
- During GC a councilor may move to amend a motion by completing the amendment form provided with the exact wording and by indicating the place in the motion for the change. Form must be submitted to the chair.
- Councilor must be recognized by the chair to verbally make the motion to amend.



• Motion to amend must be seconded.



#### **Major Rules about Motions**

- Motions must be taken up in a specific order.
- Voting on the Main Motion is always last.
- Some motions are not debatable.
- APHA has specific rules.
- Robert's Rules apply only when there are no other specific rules to cover a matter.





# **Order of Motions**

#### Undebatable

- Fix time to adjourn
- Adjourn: no further action can be taken after adopted
- Recess: GC recesses are in schedule
- Question of privilege
- Call for the orders of the day
- Lay the question on the table
- Previous question
- Limit or extend debate

#### Debatable

- Postpone to certain time: sets time for future consideration
- Commit (or Refer) to a committee
- Amend
- Postpone indefinitely: will not be considered
- Main Motion



# **APHA 15 Minute Discussion Rule**

- Each resolution, position paper, agenda item, and report is limited to discussion of 15 minutes.
- At the end of 15 minutes of discussion, the Speaker will poll the Council as to whether it wishes to spend one or more additional 10-minute periods discussing the issue.



### **Other Motions**

- Suspend the rules: most often used at APHA to allow a non-member to speak.
- **Point of order:** when a member believes that the rules are being violated.
- Appeal ruling of the chair: the method to challenge a ruling on a point of parliamentary procedure made by the Speaker/chair.
- Division of the assembly: allows for a count of the vote; not required when GC votes by machine with automatic division.



#### **Rules of Debate**

- Speaker must wait to be recognized by the chair usually the Speaker of the Governing Council.
- Each person may speak only once until all who desire to speak have spoken.
- Call others by role such as "The preceding councilor..."
- Special APHA rule—after 15 minutes of debate the Council must vote to continue discussion for 10 minutes.


