The Occupational Health and Safety (OHS) Section will be awarding scholarships that include registration for the 2018 APHA Annual Meeting (November 10-14 in San Diego, CA), a one-year APHA membership, and a \$300 stipend for conference expenses. We hope to strengthen the participation of students, worker organization and union representatives in our section at APHA. We recognize that we need the involvement of workers and new health & safety professionals to make our workplaces and communities healthy and safe.

AWARD:

The Section will directly pay the annual meeting fee, a ticket to the section luncheon at the annual meeting, and a one-year student membership to APHA with primary membership in the Occupational Health & Safety Section. Each awardee will then receive \$300 that can be used to cover transportation, lodging, and meals. Awardees will be responsible for providing the remainder of funds necessary to cover these expenses.
